SECTION C: Terms and Agreements

1. **The Property Owner** shall in all cases be liable for the charges of providing water and/or sewer service to the property.
2. **Non-Liability of District.** The District is not and will not, be liable for any loss, damage, or inconvenience to any person by reason of shortage, insufficiency, suspension, discontinuance, increase, decrease or fluctuation of water pressure including those due to power outages.
3. **Water Meter Installation.** Water meters will be installed by District personnel during normal business hours (7:00 a.m. - 3:00 p.m. Monday - Friday) **only**, as near to the desired service date as prevailing workloads permit.
4. **Service Interruption.** The District reserves the right at any and all times to shut off water delivery for the purpose of maintenance, repairs, or alterations to the system.
5. **A Backflow Prevention Device** must be installed by the property owner at their own expense if the property to be connected to the water system has another water source or potential of contamination.
6. **Applicants for New Water Service Connections** shall be required to install a pressure regulating device which will allow a maximum of 60 pounds per square inch of water pressure as measured at the most elevated or most remote point of usage on the property.
7. **Sewer Connection.** Installation of the sewer connection is the responsibility of owner, however, **All Connections Must Be Inspected** by the Tuolumne Utilities District and the Tuolumne County Building Department before backfilling during regular business hours (8:00 a.m. - 4:00 p.m. Monday through Friday). Twenty-Four (24) Hour Notice is required for inspection.
8. **Physical Connection to Sewer Shall be Completed Within Six (6) Months** of the date of this agreement. If said connection is not made within this period, normal billing will commence as of six (6) months from the date of this agreement or District may refund the connection fees and a new application and connection fees in effect at the time of re-application will be required.
9. **Septic Tank.** If an existing septic system will be abandoned due to this connection, the tank shall be pumped and filled within 30 days of the date of connection. An inspection of the abandoned septic tank by T.U.D. is required. The property owner shall notify T.U.D. upon completion of abandonment.
10. **Non-Liability of District for Sewage Backups.** In areas where there is a potential for sewage backing into the owner's building or premises from the community sewer system, the owner is required to install a backflow prevention device at the point of connection to the system or at the property line. The Tuolumne Utilities District will not be responsible for damages caused by sewage backups on the owner's premises.

I/We hereby agree to abide by and conform to the Water Rules and Regulations and the Wastewater Ordinance of Tuolumne Utilities District, governing both the sale and distribution of water, and the collection, treatment and disposal of wastewater, as now in effect or hereafter amended by the Board of Directors of Tuolumne Utilities District.
