LIMITED WATER SUPPLY - PLEASE CONSERVE WATER!
MONDAY, OCTOBER 9th TO MONDAY, OCTOBER 16th, 2017.
The PG&E Main Canal that provides TUD's primary water supply will be shut down for its annual regular maintenance during this time.
We ask that EVERYONE pitch in to help conserve water. Thank you!

Ditch Customers: There will be no water in the above listed ditches from Monday, October 9th through Monday, October 16th, 2017. Normal ditch service should resume on Tuesday, October 17, 2017. *See below for additional ditch outage periods.

Regular (Treated) Water Customers: *Please conserve water from Monday, October 9th – Monday, October 16th, 2017.* Limit outside watering - **do not wash vehicles.** Please turn off your automatic lawn and drip irrigation systems. TUD's only sources of water will be from storage tanks, reservoirs and wells. Your cooperation is requested to assure that your service area does not run out of water during the ditch outage. **The following service areas listed below are at risk of running out of water if conservation measures are not followed: (The areas noted by an arrow are at the greatest risk.)**
